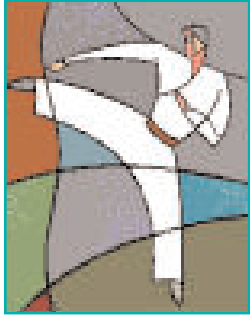

Waiver of Liability, Release, Assumption of Risk & Indemnification Agreement

The Greenwood Athletic Club (the "GAC") is a public facility owned and operated by the Greenwood Athletic Club Metropolitan District (the "District"). In accordance with my decision to use the GAC, I hereby agree to abide by the rules and regulations of the GAC as they may be amended from time to time.

For and in consideration of access to and use of the facilities, equipment, events or activities of the GAC, I hereby relinquish and release the District, the manager of the GAC (the "Manager"), and the directors, owners, employees, agents, independent contractors and consultants of the District or the Manager, now and forever, from any and all claims, demands, liability or causes of action for personal injury, property damage, or death occurring to me or to anyone else caused by or arising from my presence at or use of the GAC or GAC facilities, equipment, events or activities, which may occur on, off, or about GAC premises, including but not limited to injury or damage caused by negligence of the District. I agree to defend, indemnify and save harmless the District and the Manager, now and forever, from any and all claims or causes of action by whomever or wherever made or presented caused by or arising from my presence at or use of the GAC, # or facilities, equipment, events, programs or activities thereof.

I hereby acknowledge, understand and assume the risks and potential dangers arising from the conditions and use of GAC facilities, equipment and premises, including without limitation swimming facilities, and participation in GAC events or activities. I acknowledge and understand that included within the scope of this waiver and release is any cause of action arising from the performance or failure to perform construction, maintenance, inspection, supervision or control of GAC facilities, equipment and premises and/or from the failure to warn of dangerous conditions existing at said facilities, equipment or premises.

I, being the Parent/Legal Guardian of the child(ren) listed on my membership and/or child(ren) participating in GAC sponsored programs and events, hereby consent that photographs and/or video taken by GAC may be used by GAC for promotional materials, including the website. I understand that these photos and/or videos will be used only for promotional purposes, and will not be given to other parties for any purpose other than to promote the club. I may also request that GAC cease from using any particular photo or video in future materials or promotions, by providing written notification to the GAC General Manager or Director of Marketing. Materials that are already in existence or production at the time I provide such written notice may continue to be used until supplies are exhausted.

This agreement and the rules and regulations of the GAC, as adopted and amended from time to time, set forth the entire agreement between the District and me regarding liability. I have not relied on any representations made by or on behalf of the District or the Manager regarding this agreement. Nothing herein shall be deemed a waiver of the rights, privileges and limits on liability provided to the District by the Colorado Governmental Immunity Act, section 24-10-101, et seq., C.R.S.
